Active Enrollment 2021

Fall season at the SoNM means Benefits Enrollment. This year with Active Enrollment- 2021, there will be a few new changes to Open Enrollment. It's important to understand that this year ALL benefit eligible employees must participate by submitting one of two forms, an Enrollment/Change Form, or a No Change Form. All required supporting documentation must accompany submission of EITHER form. *Exception: New Hires in 2021 are not required to submit proof of dependency. In addition, it is required that you update your Designated Beneficiary for any life insurance coverage you carry with The Hartford, including Basic and/or Supplemental Life. • Enrollment Period: October 1, 2021-October 31, 2021 • Changes Effective: January 1, 2022.

Benefit enrollment will look a little different this year as we have updated our Employee Benefits Website (www.mybenefitsnm.com). Employees can expect a clear and easy Active Enrollment process.

ALL benefit-eligible employees must participate in Active Enrollment 2021 by submitting one of two forms, even if they are not making any changes to their benefit elections.

All required documentation must also be submitted with either the Enrollment/Change Form, or the No Change Form.

Plan design changes have been made to both BlueCross BlueShield and Presbyterian plans (Cigna plan remains unchanged). We see many of our members overpaying for their coverage

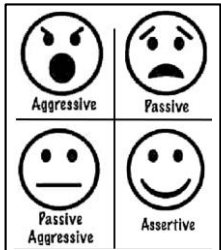
